



## **INFORMED CONSENT FOR CONSULTATION REGARDING THE CONSCIOUS CO-PARENTING INSTITUTE'S REUNIFICATION SOLUTIONS**

**A. The Conscious Co-Parenting Institute's High Road to Reunification Overview.** The Conscious Co-Parenting Institute's Reunification Solutions overview is provided to recipients solely for purposes of informing and educating them about the Conscious Co-Parenting Institute's High Road to Family Reunification program.

### **B. Intake and Consultation Introduction**

1. We receive a high volume of inquiries about *Conscious Co-Parenting Institute's Reunification Solutions*, including questions about expenses, location, enrollment criteria, and logistics. Because every case is different, the answers to these questions depend on understanding the history and facts of your particular situation. Also, it has been our experience that inquiries about *Conscious Co-Parenting Institute's Reunification Solutions* invariably lead to other questions involving concerns about attachment based parental alienation, diagnosis and the ABAB single case design model.
2. To accommodate potential applicants who are seriously considering options for dealing with alienated children, the intake consultant schedules a one-hour consultation that addresses questions about *Conscious Co-Parenting Institute's Reunification Solutions* and assists parents and attorneys in exploring various options for managing cases that involve alienated children. The intake consultant will set up the reunification consultation, which is a 60-minute session with the intake consultant. This call will be completed once you have submitted your intake form and this signed informed consent form. The intake consultant will not answer questions about your case or the program. The intake call will be a confirmation call to schedule the time and provide you with the call-in information for your reunification consultation with one of our trained reunification coaches.
3. The reunification consultation has a financial investment of \$500 for the file setup. Clients receive the benefit of our extensive experience in managing such cases and learn how to proceed if *Conscious Co-Parenting Institute's Reunification Solutions* is to be a viable option for the case. In some situations, the consultation results in the conclusion that one of our programs is not the most suitable option for the family. In such cases, though, the consultation provides clarification about the benefits and drawbacks of the alternatives. (These consultations are informational in nature for educational purposes only; they do not include the provision of psychological services such as evaluations and treatment.)
4. Before a decision to participate in an initial consultation regarding the REUNIFICATION, the client exchanges contact information with the intake consultant. The client inquiring about the HRTR program receives an "Intake Interview Form," with instructions to fill it out and send it back to the intake consultant for review. The intake consultant reviews the information, contacts the client, and provides brief feedback at no cost to the client. If after receiving this feedback the client requests a further consultation, a telephone consultation appointment is scheduled.

**C. Reunification Consultation.** If you decide to proceed with a telephone consultation, click on this link [\*\*REUNIFICATION CONSULT\*\*](#) and pay the amount of \$500 an hour for the consultation. If an initial

consultation is scheduled, the consultation in no way obligates any HIGH ROAD TO REUNIFICATION coaches to take on a case. A decision not to be involved further because of the nature of the case, appropriateness for the program or constraints of the coach's schedules may be factors.

1. Parents usually experience consultations as beneficial, regardless of the eventual outcome. Parents typically find the knowledge gained during the initial consultation very helpful with a useful understanding how best to proceed; however in some case, we may not agree to provide further services, or if the family is not accepted into one of the Conscious Co-Parenting Institute's Reunification Solution's programs.

2. Intake consultations and reunification consultations are informational educational and not psychological or legal advice or services.
